Subject: **Notification Of Intent** (NOI) to issue an Invitation For International Proposal (IFIP)

1. In accordance with the stipulations of the Bi-SC procurement directive 60-70, Annex B, the following information is provided on an Invitation For International Proposal (IFIP) that this Headquarters has the intention to release.

IFIP reference number : ACO-SH-22-14
Title of IFIP : Provision of civil works to SHAPE compound.
Requirement : The contractor shall provide general building work for SHAPE. The contractor shall be a general building contractor, expected to be competent and capable of planning, managing and delivering the following works on the SHAPE compound:
General industrial and commercial building works, refurbishments and extension; general first and second fix carpentry; brickwork, blockwork, concreting, cavity wall insulation, damp proof courses and membranes; steel framed construction and fixing; pitched and flat roofing works including profiled sheeting, felt coverings, waterproofing and guttering; wall and floor tiling, including levelling screeds and grouting; rendering and plastering, including dry lining, partitions, skimming, suspended ceiling systems; interior and exterior painting and decorating; general plumbing work including the installation and repair of sanitary ware, drainage works, ground source heating, solar heating systems; floor screeds, domestic and industrial floor coverings; glazing; Installation of exterior and interior doors, windows, shutters, blinds and window films; groundworks, tarmacking, kerbing, paving, fencing, drainage, foundations, membranes, damp proofing, landscaping and small road repairs; enabling works including services tracing, surveying, levelling, setting out, formwork, falsework, scaffolding; demolition of buildings, structures and roads.

Type of contract : Indefinite Delivery, Requirements type contract
Period of performance : One year (2023) + 4 (four) one-year options
Bidding procedure : Best value
Funding : SHAPE budget + reimbursable budgets (estimated yearly amount: 2 MEURO)
Estimated total cumulative value of contract: 10 MEURO

Issue Date : Mid-July 2022 planned
Bid Closing Date : October 2022 planned
Classification of IFIP : NATO UNCLASSIFIED
Eligibility : Firms (1) that originate and are chartered/incorporated within one of the 30 NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the 30 NATO-member nations, (3) that have performed at least three contracts within the last five years substantially similar in scope and magnitude to the requirement described in the solicitation.
